15/18 Seighford Airfield

It was felt that the newly elected borough councillors, Stephen Leighton and Ray Sutherland, should be involved as nothing new had been done.

The clerk was to request the name of the new Principal Officer so that the parish council can inform him/her of its problems with Driveme and send copies to Andy Price and John Holmes.

It was noted that the agenda had not been placed on the notice board – the clerk had sent out the agenda three nights before the meeting to the parish councillors but had missed putting it on the notice board.

Broadband – no information at the moment.

The clerk's pension was discussed. It was agreed the salary level did not attract a pension contribution.

15/25 Planning

The following planning applications had been received from SBC planning:

10 Brook Lane, Ranton – proposed two storey annex extension to front with new porch and replacement conservatory to side.

15/22267/FUL – The Cottage, Long Compton Lane – proposed development – brick built stable.

15/22319/COU – Ranton Green Farm, Brook Lane – conversion of redundant agricultural building to single dwelling & associated works.

15/22451/FUL - Yew Tree Barn, Long Compton - erection of side extension.

15/22270/FUL – Park Nook Barn, Orchard Lane – provision of hay store & three stables for horses.

The parish council had no comments except for 10 Brook Lane where there was some concern about massing and the effects on the street scene particularly as this is such a large extension.
