Local parishioners had objections regarding the proposed development including visual intrusion, negative impact on the countryside and increased traffic. It also transpired that work had started on the site before an application had been put forward.

After discussion Cllrs. Batchelor, Forrester and Williams were not in favour of the application. Cllr. MacLeod was in favour.
